NEW INDOOR POOL SCHEDULE Starting October 1

Because water aerobics exercise enhances strength and mobility for many of our residents, we are allocating 4 sessions/week in the indoor pool for self-directed water aerobics exercise. The remaining 12 sessions/week will be open swim sessions. This schedule is limited due to the requirement for sanitizing every 2 hours. Enter through fitness room door, use hand sanitizer provided, and sign Indoor Pool tracking sheet.

- * Showers and water fountains are not available.
- * Facemask is required at all times (except in the pool water).
- * Observe social distancing.
- * Use the hand sanitizer provided.

For each session,

- * Only **6** residents may use the pool at any one time.
- * **Please move aside to open the lanes for lap swimmers when necessary.**
- * Bring your own water exercise items.
- * Spa use is limited to **1** person at a time or **2** people from the same household.

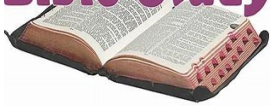
Avenbury Investment Club

Due to the "seasonal changes" and shortening of daylight, we have implemented earlier times for Pickleball in the PM.

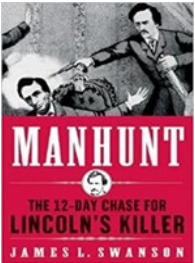

Book Club



The Avenbury Book Club will meet on October 1st at 10:30 AM in the Paver Garden sitting area behind the tennis courts to discuss the book *Manhunt: The 12 Day Chase For Lincoln's Killer* by James Swanson. The murder of Abraham Lincoln set off the greatest manhunt in American history, the pursuit and capture of John Wilkes Booth. From April 14 to April 26, 1865, the assassin led Union cavalry and detectives on a wild twelve-day chase through the streets of Washington, D.C., across the swamps of Maryland, and into the forests of Virginia, while the nation, still reeling from the just-ended Civil War, watched in horror and sadness. This is the historical tale of that chase. On November 5th we will be discussing the novel *The Post Mistress* by Sarah Blake.

The HOA asks us to limit our group to 10 people, wear masks, and maintain social distance. Please bring a folding chair to facilitate social distancing.

Quilt Club

Avenbury Quilt Club members have spent the last six months doing a variety of sewing projects to pass the time. In the window at the Quilting Bee Quilt Shop in Lakewood is this beautiful Birch Quilt sewn and quilted by Dory Grooff, a member of the Avenbury Quilt Club. Dory's niece, Sabien, who lives near Amsterdam, attended the Chelsea Flower Show in London in May, and fell in love with a row of white birches. Sabien asked Dory to create a quilt that incorporated birches, did some research, and found a picture for inspiration. Dory designed this quilt using the picture and her imagination. Dory previously made costumes and came to quilting only a few years ago when she joined the quilt club. She has been a prolific and adventurous quilter, and this is a small sample of the work she shares with the quilt club members.





Once again, Avenbury Lakes residents will be voting on **Election Day (Nov 3) at Hope Christian Church, 32625 Detroit Road, Avon**. We will employ social distancing and other new procedures to keep our poll workers and the public safe. All personnel will wear surgical masks and equipment will be sanitized between voters to make it a safe experience for all.

Anyone who wishes to vote but needs to **register or change their address** may do this online at <https://www.voteloraincountyohio.gov/> if you have an Ohio Driver's License or State ID. Otherwise, you can download the form and mail it in. **The deadline is October 5.**

In September, Ohio Secretary of State Frank LaRose mailed absentee ballot applications to every registered voter in Ohio. You may complete it and mail it or take it to the Board of Elections. Anyone can take your application for you (but not your voted ballot) if you don't want to go yourself. If you have already submitted one, it is not necessary to send another one. You can check on the Board of Elections website to see if your request has been received. I suggest giving it a week from the time you mailed it.

The actual ballots cannot be mailed to anyone until October 6. After that date, you can check online to see if yours has been sent to you yet. You can return it by mail (postmarked by Nov 2) or by taking it to the Board of Elections any time before 7:30 pm on Nov 3. There is a Ballot Drop Box available 24 hours a day if you don't wish to come inside during office hours. You can track your ballot online to see when your ballot is mailed to you, and after you return it, you can see when it is received by the Board of Elections. Just go to <https://www.voteloraincountyohio.gov/> and choose Absentee Ballot Status.

If you sent a request and it doesn't appear to have been received, or if your ballot has been mailed to you and you still haven't received it by mail after giving it sufficient time, check with the Board of Elections to resolve the issue. Please do not wait until close to Election Day, it just makes it that much harder to resolve any issues that may arise. We WANT you to vote and for your ballot to be counted!

For those wishing to vote in person at the BOE during the **Early Voting Period beginning October 6**, check the website for extended hours or call 440.326.5901 for more information. Residents who are interested in being **Poll Workers** on Election Day can call the Board of Elections for more information. Starting pay is \$150 for most positions. Most poll workers return year after year and love the experience!

Community Manager Report



***Roof Update:** Phase 4 of the Roof Replacement Project has been completed. This year 39 addresses were completed including 18 on Roxbury, 19 on Montague and 2 on Detroit. At this point, all dryer vent caps for roofs completed in the last 4 years have been inspected to make sure the screens have been removed and the duct is correctly attached to the dryer vent. Plans are in place so that this issue is not a problem in 2021. For example: our roofing contractor, Final Touch, will remove all of the dryer vent roof cap screens over the winter so they are ready to be used in the spring. “Before” photos will be taken in the attic to document the duct/roof cap connection followed by “after” photos once the new roof is complete and a certified HVAC technician makes sure the duct/roof cap connection is good.

***Community Walk:** Contractors and AL staff will continue to follow up with repairs and other items identified from the Community Walk. Please remove any items placed in Common Areas. Also, as a reminder, if you are changing something on the exterior of your home you may need approval from the **Architectural Committee** BEFORE the work takes place. This includes satellite dishes, exterior lights, security cameras, solar tubes, generators, window well covers, step and porch handrails, storm and primary door replacements, garage door replacements, window replacements and other items. Forms are available on-line and at the Information Center. **Call us if you need clarification.** Failure to get prior approval may mean that the item must be removed, and repairs made at the homeowner’s expense.

***Contact Information:** If you have changes to your Contact Information such as a **new phone number, email address or Emergency Contact**, please let us know at the Information Center. This information is helpful when we need to reach you and for the email blasts.

***Brightview:** Fall clean up begins this month and will continue till the end of the year, including leaf removal when the leaves fall. Mowing will continue through the month. Irrigation systems should be turned off now and will be winterized this month.

***Pond Banks:** Work will continue on the pond banks through the month. Earlier this year, vegetation was cut down, sprayed and woody plants removed. This month, areas on the west side of the South Pond up to the waterfall will be rototilled and re-seeded with No Mow Grasses. Eventually, all the pond banks will be treated this way to re-establish the original landscape design in this area.

***Coupon Books:** Remember to contact **Lawrence Community Management Group at (440-937-2800)** if you no longer want to use a coupon to pay your Maintenance Fee. If you continue to use a coupon, you will be charged **\$15** for the coupon book. Also, Maintenance Fees can only be accepted at Lawrence. **The Information Center DOES NOT accept Maintenance Fee payments.**

Landscape Committee News

Can you believe that it is already October? Before long the snow will be flying and all of us will be snuggled up in our homes waiting for the next planting season. However, the planting season is not over quite yet. This is the time for planting your spring flowering bulbs. Daffodils and hyacinths do well at Avenbury. Tulips are another spring bulb but they do not do well here. Tulip bulbs succumb to the appetites of the squirrels, chipmunks and other rodents and in the spring the deer feast on the newly opened tasty flowers. We lose so many tulips. Consider that when you are deciding which bulbs to plant. Remember to plant them in clusters of odd numbers of 3, 5, 7, etc. This will make a better showing than planting one at a time. A little bone meal or slow acting fertilizer in the bottom of the hole mixed with the soil will get them off to a good start. The rule of thumb is to plant the bulbs 3 times deeper than the height of the bulb. Be sure to water well and next spring you will be glad you spent the effort in the fall.

This is also the time to collect seeds from any annuals or perennials you think you would like to grow next year. Cut off the ripening seed heads prior to throwing the spent plant away. It is also a good idea to pull out the annuals and weeds and cut back the perennials to clean up the beds before winter.

Remember that you should complete a Landscape Request if you are planning any major projects in your beds. The request, once approved, is good for 6 months. Any new planting should be done before the 1st frost or in the spring.

Enjoy the month and know that all seasons have something to offer.

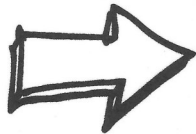
