MAIL-IN ELECTION RESULTS

Because of the Covid 19 pandemic, we could not have the usual Annual Meeting and Board Elections in 2020 and 2021. Instead, we had a special election to change our By-Laws to allow elections to be conducted via mail-in voting. The Amendment passed allowing us to conduct the first ever Avenbury Lakes Mail-In Election for Board Members.

All ballots received by midnight on July 25, 2021, were counted by a 3-person volunteer committee comprised of Bill Loucka, Bea Marlette and Mary Jo Peter. The results were shared with Nick Meinert, an attorney with Kaman and Cusimano, who certified the election results with all of the candidates. The results are:

2020 Election: Margo Hirth will continue to serve on the Board until 2022 and Robert Mazurak will continue to serve on the Board until 2023.

2021 Election: Larry Escalante and Sue Neiding will continue to serve on the Board for 3-year terms.

Thank you to the Board of Directors for your continued service! Thank you to the volunteer committee members for participating in this important election process! Overall, 75% of Avenbury Lakes households participated in this election. We would not have been able to do it without your help!

Community Manager Report

• Community Walk: Staff will soon be conducting the annual property review. We will be looking at all areas of Avenbury Lakes, letting residents and contractors know of items that need attention. The annual property review is one of many ways we ensure Avenbury Lakes continues to look it's best.



- Mature Landscaping: Avenbury Lakes is over 20 years old now. It may be time to consider refreshing and/or removing the plant material in your homeowner beds. Over time plants can simply outgrow the space they occupy and overwhelm the original landscape design. If you decide to update your beds, please call the Info Center and we can discuss the process with you including filling out a form for the Landscape Committee to review. If you are planting or removing a tree, the Landscape Committee and the Board must approve that change.
- Thistle and other weeds: Brightview uses a sub-contractor, On the Other Side, to treat thistle, apply fertilizer and grub treatment at Avenbury Lakes. On the Other Side has been on the property several times already spraying the thistle. If you see the plant turning brown it has been treated and is dying. If you do not see any brown on the thistle, please report the area to the Info Center for treatment.
- Roof Replacements: Roof work continues this month on Nottingham Parkway by our contractor Final Touch.
- Gas and Electric Line Protection: Residents may occasionally receive an offer to buy service line protection for exterior gas and electric lines to your home. Before accepting this offer, please review your Rules and Regs Handbook, "Association vs Homeowners Responsibility Chart" under Utilities and Foundations. The HOA is responsible for repairs to gas, electric, sanitary and water lines located outside of the walls or foundations of your home. You as the Homeowner would not be charged for these repairs if they were needed.
- Pond Bank Management: Landscape Architect Doug Baldi in conjunction with Brightview, Aqua Doc and On The Other Side is continuing to monitor and direct work on the Pond Banks to achieve the re-establishment of the original landscape design for this area. Work will continue throughout the year under his direction.
- Bird Disease: The Lorain County Metroparks and the Ohio Department of Natural Resources are recommending that <u>everyone</u> remove bird feeders and bird baths to limit the spread of an unknown **fatal bird disease** affecting songbirds including blue jays, common grackles, European Starlings, American Robins and House Sparrows. Please remove all bird feeders, bird houses and bird baths until more is known about this disease from the Ohio Division of Wildlife (800-945-3544). We will give an update when more information is available.
- **Brightview:** Work for the coming week is posted to the website each Monday. The pruning of new growth was completed in July. This will be done again in the Fall.
- Work Orders: If you have a Work Order request, please fill it out on the Website and hit the "Submit" button. You can also print the form from the Website and put it in the slot at the front door to the Info Center. You can also come to the Info Center and fill it out here. Please do not leave Work Order requests for Patty Hales, Lodge Administrator, as an email or voicemail.
- Autopay/Payment Coupon Books: Just a reminder that there is a \$15 charge for Maintenance Fee Payment Coupon Books. If you would like to switch to Autopay, please contact Lawrence Community Management Group (440-937-2800) for details no later than October 31st, 2021.
- Wetlands Z Bridge: The east (Jaycox side) entrance to the Long Bridge to the wetlands (Z bridge) will be roped off until late August. Please do NOT use this entrance to the Bridge until the barriers have been removed. The sandy path to the bridge in this area is being used by an insect called the Cicada Killer. This member of the Wasp family digs holes in soft ground creating burrows where they store cicadas they have killed for their larvae to feed on. They are nearly two inches long and look fearsome, but rarely sting if left alone.



Landscape Committee News



~ The summer is passing by quickly. The flowers are really showing their beautiful colors. Right now the most important thing you can do for your flowers and lawn is watering. With the temperatures in the 80's and 90's, we need to make sure that watering is kept up and adequate.

- \sim Trees need extra water during dry spells. Place the hose at the base of the tree and turn on a trickle of water. This will allow the water to be absorbed by the roots.
- ~ We all know that weeds are thriving. If you are able, try to get out and pull the weeds before they produce seed heads and reseed themselves in your bed. ~ Insects also thrive in these temperatures. There are really good products that will get rid of the insects and still be kind to the environment. The experts at the garden centers can be a good source of information on this.
- \sim As always, if the Landscape Committee can be of any help to you, please do not hesitate to ask. If we don't know the answer, we will help you find the information needed.




