## **Avenbury Lakes Annual Meeting and Elections 2025**

The Board voted on December 19, 2024, to hold a mail-in-election and a **Virtual Annual Meeting on April 22, 2025**. Using the mail-in ballot, more residents vote giving us a better representative of the community. The Virtual Annual Meeting provides the convenience of watching from home. If you do not have access to a computer, the meeting can be viewed on the big screen TV in the Activity Room at the Lodge. More information on accessing the Virtual Annual Meeting will be shared with all owners in the April Breeze.

The Nominating Committee, consisting of Larry Escalante, Bob Sexton, and Gary Hawkinson, has been approved by the Board of Directors.

#### This year there will be two open seats on the Board:

- Phyllis Neidhardt's current term will end in April of 2025.
   She is seeking re-election.
- Bob Kennedy's current term will end in April of 2025. He is seeking re-election.

Residents who wish to serve on the Board of Directors are encouraged to nominate themselves. Before nominating another resident within the community, please discuss with them to ensure they are willing to serve on the Board of Directors. All interested members must submit a letter of interest or intent along with a one-page biographical piece to be submitted to the Information Center **no later than March 6, 2025**. Qualifications to serve as a member of the Board include being an owner of record and an association member in good standing (current in your assessments and free of any maintenance or rules violations).

Candidate information and ballots, along with postage-paid envelopes for returning the ballots and an explanation of how we will maintain the secrecy of the votes, will be mailed to all association members at least 35 days before the election results meeting.

On Tuesday, April 21, 2025, The Nominating Committee chosen by the Board will verify and count the ballots. Then, that same day, a special election results meeting will be conducted via video conference. Attendance at the election results meeting will be limited to a representative from our legal counsel, the election committee chairperson, the candidates, the Community Manager, and the current Board Members.

The results will be announced at the Annual Meeting, April 22, 2025, in the May Breeze, and on the Avenbury Lakes Community Website.







**Autopay Update Reminder**: Please remember to update your online or autopay amounts to reflect the increase in your monthly assessment beginning January 1, 2025.

You can view your account balance by logging into PORTAL.LAWRENCEMANGEMENT.COM. If you don't have an account, new users can set one up in Vantaca to view your account.

You may also contact the accounts receivable department at Lawrence Management by calling 440-937-2800 to check on your current balance or with questions on setting up your Vantaca Account.

**Winter Events:** Information and updates related to winter weather events will be posted on the community website, avenburylakes.com. This is also a reminder that snowfall must exceed 2" before snow removal activities begin. During any winter event, we encourage you to use caution when venturing outdoors. This is a reminder to avoid placing any Holiday decorations such as extension cords where damage may occur by snow removal equipment. This includes front walks, porches, driveways, and driveway edges. Brightview will make every effort to clear the snow as soon as possible. In the event of a large snowstorm, it may take more than one day to clear snow in all areas.

#### Vantaca: What is it and why should I register?

Vantaca is your community's online portal, which Lawrence Management provides. While residents are not required to register on the Vantaca Community Portal, we do strongly encourage you to give it a try, as Vantaca offers many benefits to unit owners.



The portal allows you to easily pay your monthly assessment, view your personal account information, enter and track your maintenance requests, receive electronic notifications about Association events and other important messages, and more. If you have not done so already, it's never too late! For instructions on how to register, please reference the recent budget notice on the reverse side of the letter that was sent to you in the mail or feel free to contact the Information Center for instructions.

# Reminder for Sign-up and Payment Procedures for Social Events

- New sign-up sheets will be placed in the Activity Book on the first weekday of each month.
- Sign one name per line; couples are not to be listed on a single line.
- Payment for an event is required at the time you sign up. Your payment holds your reservation. There will be a cutoff date for receiving payment for each event, and there will also be a two-week cut-off before the event for refunds
  if you are unable to attend.
- The committee will NOT call each resident if payment is not received by the cut-off date. Your name will be deleted
  from the list.
- When the maximum number of spaces has been filled, the names are entered on the waitlist on the sign-up sheet for the event. Do not pay if you are on the wait list unless you are called by a member of the committee notifying you that there is an opening.
- Payments can be made by cash or check. Place cash in an envelope marked with your name and the event for
  which payment is made. If paying by check, write the event's name on the memo line and put the check in the box
  on the desk. An envelope is not necessary for a check.
- All checks are to be made payable to ALHOA.
- A separate payment is required for each event. No post-dated checks will be accepted.

There's no denying that recycling is an earth-friendly habit that can help keep our environment clean, conserve natural resources, and cut down on pollution while benefiting the economy. And it's important we all do our part. **But, are you recycling the right way**?

<u>Don't Recycle Anything Smaller than a Credit Card</u> - In the quest to be a recycling guru, you may be tempted to recycle every little thing you can. But, small pieces like bottle caps, shredded or tiny pieces of paper and can tabs can get stuck in recycling processing machines. When in doubt, do the credit card test. If it's smaller than a credit card, toss it in the trash.

<u>Keep Things Loose! Don't Ever Bag Recycables</u> - Bagging recyclables poses challenges at the sorting facility, especially if the bags aren't recyclable themselves. Keep recyclables loose unless instructed otherwise by your local recycling company. The only exception to this rule is shredded paper, which can be contained within a paper bag.

<u>Empty, Clean and Dry! Let That Be Your Recycling Motto</u> - In many households, food and drink containers account for the majority of what ends up in the recycle bin. But did you know that putting just one food-covered container in the recycle bin can contaminate an entire truckload of recyclables? So don't toss dirty bottles of leftover ketchup or sticky peanut butter jars into the recycling bin. Ask yourself if it's empty, clean and dry. And when in doubt, throw it out.

#### Here's What You Can and Can't Recycle

Paper! - Paper should never be wet, sticky or mixed with other types of materials — like sticky notes, bubble wrap mailers, or envelopes with a clear plastic window. **Used coffee cups are also a no-no.** Newspapers, mail and magazines, office paper, and notebook paper get the recycle bin green light. **Junk Mail can be loose or in a paper bag with the top open**.

**Cardboard!** - <u>Clean cardboard</u> from moving and shipping and food boxes (like cereal, cracker or cookies boxes), as well as juice and milk containers (as long as they're rinsed out) are recyclable. The <u>non-greasy side of a pizza box</u> is okay too. Just tear off the dirty side, throw it away and put the clean side in the recycle

Plastic bottles and jugs! - When it comes to plastic, make sure anything you toss in the recycle bin is always empty, clean and dry! No food residue of any kind will do. It's also a good idea to try the "poke test." If you can press your finger through the plastic, it shouldn't go in the recycling bin. This rule applies to sandwich bags, plastic wrap and plastic grocery bags. You can usually bring grocery store bags back to the store for recycling. No Clamshell or plastic containers from fruit or leftoyers.

Aluminum soda cans, tin cans and aluminum foil (unspoiled)! - Soda cans, as well as soup, tuna and bean cans, are recyclable. Again, just make sure they're empty, clean and dry! Give them a rinse and tip them over to drain before tossing in the recycle bin. Clean aluminum foil that isn't contaminated with food is also acceptable. Never include aluminum foil with food stuck to it, bottle caps, soda can tabs (on their own) or razor blades.

**Glass? It depends...** While glass is a recyclable material, check with your local municipality to see what's accepted. Never put broken glass in the recycling bin. Whether it's broken window glass or a broken beer bottle, just don't do it. It can clog machinery and be dangerous for workers handling the recyclables.

No batteries or electronics

No food or food-contaminated items of any kind

No foam

No single-use utensils, paper plates, napkins or paper towels

No plastic sandwich bags, plastic wrap, or plastic grocery bags

Here are a few easy changes you can make to reduce the amount of waste in your home:

- Pass on plastic bags! Bring reusable tote bags when shopping for groceries or other items.
- Get a portable reusable water bottle (stainless steel is great!)
- Bring lunch to work in reusable food containers.
- Reuse food jars (they're great for freezing soups and sauces)
- Donate or repair items instead of throwing them away.

## The Story of Groundhog Day - Why Celebrate a Rodent?



There are religious holidays of all types, national holidays that honor heroes and events, and even silly holidays like National Candy Corn Day that we celebrate "just for fun." But a day devoted to a chubby rodent that spends a lot of time underground? Now that's a holiday worth discussing. Like many unusual holidays, this one goes back centuries. Early European Christians celebrated the Feast of the Presentation, honoring the day when Mary and Joseph first brought the infant Jesus to the Temple in Jerusalem, 40 days after his birth on Christmas Day. Later, this became the day when priests blessed the candles—candle mass—used in this celebration. Candlemas Day, February 2, merged with other pre-Christian celebrations, marking the first possible day when hibernating animals might awaken at the end of winter.

Candlemas Day and the Hedgehog - Ancient wisdom from the United Kingdom maintains that if there is nice weather on Candlemas Day, harsh winter weather will follow: "If Candlemas Day is clear and bright, Winter will have another bite. If Candlemas Day brings cloud and rain, Winter is gone and will not come again." The Romans brought the Candlemas Day weather superstition north to the Germanic peoples they encountered during their conquest of northern Europe. The Germans incorporated it into their own folklore. They concluded that if the hedgehog, a common hibernating animal in their area, awoke to sunshine on Candlemas Day, he would cast a shadow and thus predict continued winter weather.

The Beginning of Groundhog Day in the United States - It's likely that German immigrants brought the story of the hedgehog with them when they came to the United States. And while they brought the tradition, they could not bring the hedgehog. Another native hibernating animal—the groundhog, or woodchuck, as it is also called—was substituted. The groundhog/woodchuck was a good choice because it was considered a "wise and sensible animal" by many Native Americans and figures prominently in their creation stories. Thus, Groundhog Day was born in the New World. According to tradition, on February 2 of each year, the groundhog leaves its burrow (where it has been hibernating through the winter) to see if the cold weather is still in full force. If the groundhog cannot see its shadow, it is said to remain aboveground, effectively ending its hibernation. However, if it sees its shadow (if the sun is shining), the groundhog returns to its burrow, and we can expect six more weeks of cold weather... or so the story goes.

<u>Punxsutawney Phil</u> - The most famous weather-forecasting groundhog is Punxsutawney Phil. He resides in Punxsutawney, PA where they hold an official ceremony every February 2. Here are some fun facts about Phil:

- Phil is 138 years old, having been predicting the weather since 1887.
- Phil's overall accuracy rate is 39% over 135 years, but the Punxsutawney Groundhog Club claims he is correct 100% of the time.
- Punxsutawney Phil has visited the White House and The Oprah Winfrey Show.
- During Prohibition, Phil threatened 60 weeks of winter on the Punxsutawney community if he wasn't allowed one drink.
- On February 2, 1981, Phil wore a yellow ribbon in honor of the American hostages in Iran.
- In 1993, Groundhog Day was released starring Bill Murray. Afterwards, crowds numbering as high as 30,000 have visited Phil in Punxsutawney.

## Charitable Donations Can Remedy Your RMD Tax Burden

If you're over age 73, you must take required minimum distributions (RMDs) from your retirement accounts each year. The penalty for not taking a required minimum distribution (RMD) in 2025 is 25% of the amount that was not withdrawn. However, if the missed RMD is corrected within two years, the penalty is reduced to 10%. But what if you don't need the income? What if taking the RMD will increase your tax burden or Medicare insurance premiums?

## Enter: The Qualified Charitable Distribution (QCD).

To avoid receiving your RMD as income, you can transfer up to \$110,000 from your IRA to a qualified charity. This satisfies your RMD and prevents any unwanted additional income that would increase your tax burden. Importantly, a donation you make from income you've already received doesn't qualify as a QCD.
